A Season of Remembrance

On Saturday, **November 1**, we celebrate the Solemnity of All Saints (not a Holy Day of Obligation this year) honoring all the saints, known and unknown. All Saints Day Masses will be at 8am and 12:10pm (celebrated by **Cardinal Wuerl**) on Saturday, **November 1**. First Saturday Devotions are cancelled that day.

On All Souls' Day, celebrated on Sunday, **November 2**, we commemorate deceased family members and loved ones who await their purification in Purgatory. The Church teaches that some sins can be forgiven even after death (CCC 1031). While these departed souls can pray for us, they can no longer pray for themselves. That spiritual work of mercy is up to us. We are encouraged to pray for our departed loved ones and all souls who await the resurrection of their bodies in Christ. **Cardinal Gerhard Muller**, Prefect of the Congregation for the Doctrine of the Faith, will celebrate the 11:30am Mass on All Souls' Day.

We remember our deceased loved ones in a special way throughout the month of November with a special Mass offered each day at the Cathedral for this intention. Special envelopes are provided in the pews so that you can list the names of the deceased to be remembered at these daily Masses. The envelopes, which can be dropped in the collection basket or at the rectory, will be placed on the altar in the Wedding Chapel. We are honored to offer on **November 2** at 7:30pm a special All Souls' Day **Concert of Remembrance** and prayer, featuring the *Schola Cantorum*, for our Cathedral friends and family who have died. Liturgical Ministries Need Volunteers

In mid-September we published a bulletin flier describing the principal ministries associated with Liturgy of the Eucharist (Mass). Some may remember when only the priest and one or two servers were needed to minister at Mass. With the reform of Vatican II, the ministerial role was significantly expanded to involve lay people as lectors, servers, and hospitality and communion ministers. With seven weekend Masses and four Masses daily during the week, our liturgical ministry needs are substantial. We are indebted to the volunteers who serve in these ministries. **We are now experiencing a critical shortage of ministers**. I ask you to consider seriously giving of your time and talent to help our community in celebrating the liturgy. I hope that you will help us by volunteering for one of these ministries; the more we have, the easier the task is for all. On the Way—Advent and Adopt-a Family!

Last Christmas, thanks to the enormous generosity of time and treasure of our parishioners, we assisted 56 families (226 people) and 65 guests of the parish's weekly Homeless Ministry program. We were also able to supply gifts for two households of the L'Arche Community which serves adults with intellectual disabilities. We are asking once more for your support in demonstrating love and concern for these individuals and families during this Christmas Season. 175th Anniversary of St. Matthew's Parish

Before you know it, we will be celebrating our 175th anniversary as a parish. St. Matthew's was established in 1840 at 15th and H Streets, Northwest. The present church was begun in 1893. **We will commemorate our anniversary with many events in 2015**, including an ecumenical prayer service, a gala, a major bilingual Mass with Cardinal Wuerl followed by a reception, concerts, a very special lecture, and a reunion of former priests and staff members!! I will feature the anniversary in my November letter. It will be a time to remember, to celebrate, and to renew our efforts at spreading the joy of the Gospel. Stay tuned!

Parish Finances

Enclosed is our financial statement for 2013-2014 and our budget for 2014-2015. Last year was another year of deficit. The Easter offertory collection was down again, and the total offertory collections were up by only \$1705. Poor box and sacramental (weddings) offerings were down by quite a bit. Compared to last year, income remained nearly the same, while both expenses and the deficit were less.

Most of the deficit was paid from our special operating investment fund. The depletion of that fund **must** stop. **I am asking every household to prayerfully consider making a sacrificial contribution, the specific amount remaining between you and God.** Fewer than one-third of our households have given a recognizable offertory gift. Even a small gift from the other two-thirds would make a REAL difference in meeting our needs. Faith Direct provides an easy way to contribute (www.faithdirect.net; Church code DC284). If each household for whom we have no record of a gift were to give \$1 weekly via Faith Direct, we would have an additional \$100,000 this year for our work of building up God's Kingdom!

Planned gifts provide important resources to further the Cathedral's 174-year old mission of continuing Christ's work here on earth. Do your estate plans reflect good stewardship? **Bequests** allow you to leave something to your parish without loss of comfort or security in your lifetime. If your estate is subject to estate tax, your gift is entitled to an estate tax charitable deduction for its full value. **Securities** are another option. The best stocks for charitable giving are those that have increased in value, particularly those producing little income. Selling the stock would require payment of capital gains tax. Increases in value of donated stocks, however, are exempt from capital gains tax.

To those who give each week and in so doing, make a real sacrifice, I am so very grateful. You keep us afloat and keep all of our programs going. Thank you so very much. Muchas gracias.
