My dear parishioners,

As I sit here at my desk, so many thoughts swirl around in my mind. Hurricane Michael is ready to strike the panhandle of Florida. Fall Liturgical Highlights

At our **Fall Anointing Mass** this past Sunday, **October 21**, the sacrament was celebrated at the regular 11:30am Mass. The next Anointing Mass will be celebrated at the regular Sunday 1pm Spanish Mass on February 10, 2019. Watch the mid-January bulletins to find out how you may participate.

All parishioners, but especially liturgical ministers of the Cathedral, are encouraged to attend a Liturgical Ministry Day on Saturday, October 27 from 9 to 11:30am. We are delighted to have our own Tom Stehle, Pastoral Associate for Liturgy and Director of Music Ministries, as the main presenter. He has recently spoken to the liturgical and lay ministers in two archdiocesan parishes. Two years ago, he gave a well-received talk on the Eucharist here at St. Matthew's.

The White Mass honoring the gifts of those with special needs will be celebrated on Sunday, **October 28** at 11:30am. This Mass was begun with the vision of the Eunice and Sargent Shriver family and is sponsored by the Archdiocesan Office of Special Needs Ministry. Come join the celebration.

On Sunday, **November 4**, a special blessing of engaged couples will be given during the 11:30am Mass.

A Season of Remembrance

On Thursday, **November 1**, we celebrate the Solemnity of All Saints, a Holy Day of Obligation honoring all the saints, known and unknown. Masses will be at 5:30pm on Wednesday, **October 31**, and at 7am, 8am, 11am, 12:10pm, 5:30pm and 7pm (Spanish) on **November 1**.

On All Souls' Day, Friday, November 2, we commemorate deceased family members and loved ones. We pray for our departed loved ones and all souls who await the resurrection of their bodies in Christ. We follow the regular weekday Mass schedule that day.

We remember our deceased loved ones in a special way in November. Each day a special Mass is offered for this intention. Special envelopes are provided in the pews so that you can list the names of the deceased to be remembered at these daily Masses. The envelopes, which can be dropped in the collection basket or at the rectory, will be placed on the altar in the Wedding Chapel.

This year's All Souls' Concert will be held on Sunday, November 4 at 7:30pm as we remember deceased members of our families and friends, especially those who have died in the past year. We also will remember those lost in natural disasters throughout the world, those lost due to war and persecution in the Middle East, and those buried this year from the Cathedral. Parish Finances

Enclosed is our financial statement for 2017-2018 and our budget for 2018-2019. Total income was up by only \$24,540. Operating expenses, however, increased by \$143,310! As you can see, we ran a deficit. While our income has plateaued over the last several years, the present year's income to date shows that we are now trending below that plateau. On the expense side, as we happily note the 15th anniversary of the restoration of the Cathedral (can you believe it's been 15 years since the scaffolding?), "things happen" regularly that need attention—and they all cost money. Of course, other parish expenses also tend to pop up.

St. Matthew's is a vibrant community with deep commitments to stewardship that enable us to minister to **2000+ people at 7 Masses each weekend** and to deliver on many ministry priorities, particularly in the areas of social justice and faith formation. To maintain our strengths and meet new parish needs, **parishioners must develop their own prayerful commitment to stewardship** at St. Matthew's.

As I wrote to you in September, while over 2,300 households are registered, in the last fiscal year only **869 could be identified as making offertory contributions!** We aim to increase the overall offertory and **to engage many of the remaining 1,400+ parish households in regular financial sacrificial giving**—the fuel for our parish mission as the hands, voice and face of Jesus.

I remain grateful for your love and service to our parish.
