My dear parishioners,

This month I am enclosing our financial statement for 2010-2011 and our budget for 2011-2012, and a special letter regarding the parish's stability. It is time for serious thought and a realistic perspective. I am asking everyone in the parish to make a sacrificial contribution. I am not asking for a specific amount—this remains up to you and God. Currently, fewer than one-third of our households have given a recognizable gift in our offertory. A small gift from the other two-thirds-plus would make a REAL difference. To those who already give each week and in so doing, make a real sacrifice, I am so very grateful. You keep us afloat and keep all of our programs going. *Thank you so very much. Muchas gracias*. Please see my letter and the statement for a clear picture of our financial outlook.

A Busy Start to Fall

October is quickly winding down; thank God for all the sunshiny Fall days! It seems only yesterday that I was dozing at twilight on the beach at Emerald Isle. Since my return, the pace has been nonstop and invigorating—weddings, the Feast of St. Matthew, the Parish Mission, our Fall Lecture Series, the Red Mass, Alumni Days at my alma mater, Theological College, the Anointing Mass, and all the regular parish events and liturgies. My responsibilities as Dean of the Northwest West Deanery brought more activity. Before you know it, Thanksgiving will be here, as will the new translation of the Roman Missal.

November Celebrations

All Saints Day. Join us on the Solemnity of All Saints, a Holy Day of Obligation, celebrated at the Vigil Mass at 5:30pm on Monday, *October 31*, and at Masses at 7am, 8am, 11am, 12:10pm (celebrated by *Cardinal Wuerl*), 5:30pm and 7pm (Spanish) on *November 1*.

All Souls Remembrance. November presents a special opportunity to come together in Christ Jesus to remember and pray for the Poor Souls—those who have died in the friendship of God but still have some purification to undergo for the sins they committed during their lives on earth. Traditionally, we Catholics remember our deceased loved ones in a special way throughout the month. Join us on November 2, All Souls' Day, when Cardinal Wuerl will celebrate the 12:10pm Mass. In addition, we will offer a special Mass each day during the month. A special envelope is enclosed (and is also available in the pew racks) so that you can list the names of deceased to be remembered at these daily Masses. Please return the envelope to the Rectory or place it in the collection basket at your convenience.

Adopt-a-Family. Last Christmas, thanks to the enormous generosity of time and treasure of our parishioners, we assisted 35 families and the clients of the parish's weekly Homeless Ministry program. This year has been even more difficult for families and we are asking for your support. Advent & Christmas Liturgies & Events. My Thanksgiving letter will include the Advent and Christmas brochure with a fully detailed schedule. Highlights during Advent include our Day of Recollection on Saturday, *December 3*; the Solemnity of the Immaculate Conception on Wednesday *December 8*, a Holy Day of Obligation; on Sunday, *December 11*, the Feast of Our Lady of Guadalupe celebrated at the 1pm Mass followed by a reception, and Lessons & Carols at 7:30pm that evening; and on Tuesday, *December 20*, our Communal Penance Service at 12:10pm.

St. Matthew's Christmas Cards. Speaking of Christmas . . . boxed sets of our beautiful Christmas cards featuring the St. Matthew's Crèche scene in full color are now available for purchase at the rectory. The cost is \$15 for a set of 10 cards and envelopes. The rectory opens at 9am every day and closes at 8pm. Monday through Thursday and at 4pm on Friday through Sunday. Special Parish Needs

Thank you! Special needs always crop up in parishes—needs that cannot be funded in the general operating budget. I am so very grateful to those who have responded to my recent requests. To date, we have received pledges for the New Roman Missals, one ordination dalmatic, two white chasubles, pew cards and the re-printing of the Latin Mass books. Another need in that vein is the replating of the 8 chalices used to give Holy Communion under both forms. One estimate for this project is \$500 per chalice, though I intend to get some other proposals before proceeding with this request.

Security Presence in the Cathedral. For several periods of time each week, the Cathedral is open to the public without the continuous presence of a sacristan. In the absence of a sacristan or another Cathedral representative, our rules of conduct are often violated in ways that interfere with the peace, sanctity and safe sanctuary of the Cathedral. After consulting with my staff and the Parish Pastoral Council, I have decided to pursue a trial solution—the hiring of an unarmed security guard to be present in the Cathedral for approximately 20 hours per week at a cost of approximately \$5,000 for a 3-month trial period. This will be possible only if we can fund the cost with donations for this special need. If the trial is successful, we will address future funding needs as they arise, including building the cost into our operating budget for the next fiscal year. My dear parishioners,

I ask you to reflect for a moment on what St. Matthew's Cathedral Parish means to you. Has St. Matthew's made a difference in your life or the life of your family? Do you have warm memories of the priests, past and present, who have served you here? Maybe you were married or had a child or children baptized here. Maybe you were introduced to the teachings of the Church through our RCIA or learned more about them through our Faith Formation programs. Perhaps you made friendships through our many volunteer ministries or our Young Adult activities. Whether as a friend or parishioner, old or new, each of us is a beneficiary of more than 171 years of service and parishioner generosity.

In light of your experiences, I invite you to consider how you can help secure the future of this parish with your time, talent and treasure. The last few years have been a struggle for St. Matthew's to meet its financial obligations. For example, *last year's financial statement* (*enclosed*) *shows that we were in the red by \$99,560*. I might add that the deficit included the effect of assessments paid to the archdiocese. To pay for those, we recently took funds from our investments. That operating fund is being depleted very quickly—not good!

A parish cannot survive without the generosity of its parishioners. Inflation has surpassed the old tradition of throwing "a dollar into the basket" during the offertory collection. I encourage you to make a thoughtful and sacrificial contribution to our parish. To maintain our current staff positions and other paid personnel (including visiting Mass celebrants and those choir members who are paid), pay our archdiocesan assessments and our own bills, maintain our ministries, continue to serve our community and reach out to those in need, and promote the *New Evangelization*, *I ask you to help us erase the existing deficit in this year's budget* (\$75,301).

Thank you to those who are generous week after week. A few are *extremely* generous. The Bible speaks of a tithe of 10%. Some interpret that to mean 5% to your Church and 5% to other charities. How close do you come to that formula? You may not be able to reach that goal right now, but I would ask you to start. To those parishioners who have not given any recognizable gift at all, try to commit to something each week. You can set the amount. Any amount will help to make a real difference. Together we can actually make our modest budget work—without cutting into our investments. I know we can do it!

St. Matthew's accepts contributions via weekly offertory envelopes, automatic account withdrawal and credit card charges. All automatic payments are done through Faith Direct, offering a secure way to give even when on vacation, away on business, or prevented by illness from attending Mass. To enroll, visit their website at www.faithdirect.net and use our parish code (DC284), or call 1-866-507-8757 for more information.

I also invite you to consider how you can play a role in securing the future of this parish with a planned gift. Many planned giving options are available, including naming the parish in your will or estate plans, or naming the parish as a beneficiary of your life insurance or retirement plan assets. I encourage you who love St. Mathew's to consider making a planned gift that, God willing, will sustain this good work we know as St. Matthew's Cathedral parish.

To recap, I am asking you to help St. Matthew's by doing three things:

First, give a sacrificial gift regularly,

Second, *give your gift in a recognizable way*, and in particular, consider using Faith Direct, and

Third, include St. Matthew's in your planned giving.

I ask this, as I do all things, for the greater glory of God. Thank you for your consideration
