Away on vacation? With Faith Direct, you need not worry about when to catch up. I know from personal experience—when I was away, I regularly forgot to make up missed contributions. Now that I am one of the 335, I have nothing to worry about! Last year at this time, I was looking for 500 participants in a year's time. While we did not reach that goal, I am encouraged by the sign-ups thus far; let's see if we can do it by June 2012! Health & Wellness Fair—A Great Opportunity to Care for Yourself & Your Family

This year's **Health & Wellness Fair** sponsored by St. Matthew's Social Justice & Community Services Committee will be held on Sunday, *September 11*, 10am to 3pm, in the North and East Conference rooms, with expanded services, information and education! Flu shots and pneumonia vaccines will be available. We also will offer bone density, blood pressure, cholesterol, body mass index, vision/glaucoma, blood glucose, posture, balance, strength, HIV and other screenings by Holy Cross and Providence Hospitals, the Spanish Catholic Center, La Clinica del Pueblo, Friends of the Congressional Glaucoma Caucus Foundation, and GW University. Also in attendance will be a general practitioner, dentists, American Diabetes Association, National Alliance on Mental Health, The Washington Home and Community Hospices, and the Archdiocese of Washington, offering education and information on general health, nutrition, cancer, advanced directives and other end of life issues and access to health services. Take advantage of the fair to care for yourself and your family!

Other Ways to Participate and Grow at St. Matthew's This Fall

Fr. Jack Hurley will offer a five-week course on the **Prophets of the Old Testament** on Saturday mornings this fall beginning on *September 10* from 10:30 to 11:45am. Bring a Bible, and consider staying for the 12:10pm Mass. All are welcome!

Fr. Kevin O'Neil, CSsR, friend of the Cathedral and current associate professor of moral theology at Washington Theological Union, will give our **Parish Mission** – "The Gift You Have Received, Give as a Gift: Sharing the Grace of the Sacraments" – to be held *September 17-20*. Please join us as we reflect on our journey to fullness of life in Christ, a journey that calls us to share the love so generously given by God and to

build up the body of Christ. Fr. O'Neil will preach at the 5:30pm Mass on the 17th as well as the 7am, 8:30am, 10am, and 11:30am Masses on the 18th. He will give reflections at 7pm Sunday through Tuesday in the Cathedral and abbreviated reflections following the 12:10pm Mass on Monday and Tuesday.

This year's **Fall Lecture Series** will focus on "**Exploring the New Evangelization**," our mission set forth by Pope Benedict XVI to renew our faith and invite others to rediscover Christ and his message. Our five-part series will begin with a talk on Catholic identity in the third millennium and continue with talks on understanding the New Evangelization and what it means for our personal renewal, our parish vitality and our social mission. The series will begin Wednesday, *September 28* and Thursday, *September 29* and continue every Wednesday and Thursday in October. Wednesday lectures will be from 12:45 to 1:45pm in the North Conference Room. Thursday lectures will be from 7 to 8pm in the North Conference Room.

Once again, St. Matthew's will host the annual John Carroll Society lecture this fall. Author and theologian Father Robert Barron of the Archdiocese of Chicago will speak on "Culture Cries Out for Christ: Evangelizing Today's Society" at 6:45pm on Tuesday, *September 13* in the Cathedral.

On Sunday, *October 2*, Cardinal Wuerl will celebrate the annual **Red Mass** at 10am. The 8:30am Mass is cancelled that day. At the Red Mass, we welcome members of the U.S. Supreme Court and many judges, lawyers and other members of the John Carroll Society. The side chapels will be available to nonmembers on a first-come, first-served basis, with doors opening at 9am. Please plan accordingly.

The monthly series of talks by **Msgr. Peter J. Vaghi**, pastor of Church of the Little Flower in Bethesda, MD and John Carroll Society chaplain, will resume at St. Matthew's on Thursday, *October 6*. Msgr. Vaghi will speak on prayer at 6pm (following the 5:30pm Mass) in the East Conference Room.

More than twenty people have inquired this summer about becoming Catholic. We are always looking for sponsors to journey with these women and men through the **RCIA process**. Sponsors often report how much they learned and grew in their own faith by accompanying a person who is preparing to enter the Catholic Church. 

Faith Direct is a secure system that works directly with your bank or credit card—much the same as other direct payments you may have set up for utility bills or mortgage payments.

When do transactions take place?



Transactions take place once per month on the 4th or the next business day. The total amount of your gifts for that current month (both offertory & second/special collections) will be debited in one monthly total. The Cathedral will receive the funds 4 business days later.

Can I stop, increase, or decrease my payment at any time? Yes, by calling Faith Direct at 1-866-507-8757 (toll free) by emailing info@faithdirect.net, or by logging in to your account through www.faithdirect.net.

How does the Cathedral benefit from my participation with Faith Direct?
