A Season of Remembrance

Special Liturgies ~ On Thursday, **November 1**, we celebrate the Solemnity of All Saints, a Holy Day of Obligation honoring all the saints, known and unknown. **Cardinal Donald Wuerl** joins us as celebrant of the 12:10pm Mass. "Exactly as Christian communion among fellow pilgrims brings us closer to Christ, so our communion with the saints joins us to Christ, from whom as from its fountain and head issues all grace, and the life of the People of God itself." (Catechism of the Catholic Church (CC C) 957) All Saints Day Masses will be at 5:30pm on Wednesday, October 31, and at 7am, 8am, 11a.m, 12:10pm, 5:30pm and 7pm (Spanish) on Thursday, November 1.

On All Souls Day, celebrated on Friday, *November 2*, we commemorate deceased family members and loved ones who await their purification in Purgatory. The Church teaches that some sins can be forgiven even after death (CCC 1031). While these departed souls can pray for us, they can no longer pray for themselves. That spiritual work of mercy is up to us. We are encouraged to pray for our departed loved ones and all souls who await the resurrection of their bodies in Christ. **Cardinal Wuerl** will celebrate the 12:10pm Mass on All Souls Day, which is also First Friday, with Exposition of the Blessed Sacrament following the Mass until 5pm, as usual. The regular weekday schedule of Masses will be observed that day.

We remember our deceased loved ones in a special way throughout the month of *November*. Each day a special Mass is offered at the Cathedral for this intention. Special envelopes are provided in the pews so that you can list the names of the deceased to be remembered at these daily Masses. The envelopes, which can be dropped in the collection basket or at the rectory, will be placed on the altar in the Wedding Chapel.

Concert of Remembrance ~ On Sunday, **November 4** at 7:30pm, join us for a special concert for Cathedral friends and family who have died, featuring St. Matthew's *Schola Cantorum* and String Orchestra, and Paul Hardy, Cathedral organist. You are invited to have deceased loved ones remembered at the concert and included by name in the printed concert program. Fall Lectures ~ Our Fall Lecture Series on the Second Vatican Council continues with "On Revelation: 50 Years of *Dei Verbum*" by Dr. Brian M. Doyle, chair of the Theology Department at Marymount University, on Wednesday, **October 24**, or Thursday, **October 25**. The series concludes with "On the Church in the World: 50 Years of *Gaudium et Spes*" by Dr. H. Richard McCord, retired executive director of the United States Conference of Catholic Bishops Secretariat of Laity, Marriage, Family Life, and Youth, on Wednesday, **October 31** and by Ms. Sheila Garcia, current associate director of the same office, on Thursday, **November 1**. Lectures are in the North Conference Room from 12:45 to 1:45pm on Wednesdays and 7 to 8pm on Thursdays.

Jack Hurley will offer a five-week course on the Historical Books of the Old Testament on Saturdays, **October 27** and **November 3**, **10**, **17** and **24** from 10:30 to 11:45am. Advent & Christmas Liturgies & Events ~ My Thanksgiving letter will include, in addition to a reminder of our Thanksgiving Day Masses, the Advent and Christmas brochure with a fully detailed schedule. Highlights include the Solemnity of the Immaculate Conception on Saturday, December 8, a Holy Day of Obligation, with our Advent Day of Recollection beginning at 9am that day and ending with Cardinal Wuerl's celebration of the Holy Day Mass at 12:10pm; on Sunday, December 9, the celebration of the Feast of Our Lady of Guadalupe at the 1pm Mass followed by a reception; our Festival of Lessons & Carols at 7:30pm on Gaudete Sunday, December 16, followed by a parish singalong; and on Tuesday, December 18, our Communal Penance Service at 12:10pm.

Parish Finances

Our Financial Picture ~ I am enclosing our financial statement for 2011-2012 and our budget for 2012-2013. On paper, we were in the black last year. Don't jump for joy just yet, though, as several large bills were not paid until the new fiscal year. Reviewing our finances brings to mind how very grateful I am for those who support the parish week after week. One special blessing this past year was a large bequest that *really* helped to balance the budget.

Our Shared Obligation ~ A realistic perspective is needed. I ask *every household* to make a sacrificial contribution, the specific amount remaining between you and God. Fewer than one-third of our households have given a recognizable gift in our offertory. Even a small gift from the other two-thirds would make a REAL difference in funding our parish operations. Our heating and air conditioning bills, staff and clergy salaries, funding for the poor and homeless, the costs of the music events that so many enjoy, and other expenses of our parish must be borne. An easy way to help us and yourselves as parish members is to use *Faith Direct*—set the amount you want to give, large or small. If each household for whom we have no record of a gift were to give \$1 a week via *Faith Direct*, we would enjoy additional annual income of nearly \$100,000 for our work of building up the Kingdom of God!

To those who give each week and in so doing, make a real sacrifice, I am so very grateful. You keep us afloat and keep all of our programs going. *Thank you so very much. Muchas gracias.*
